### RESPONSIBILITIES

Our Cleantech Policy Manager Germany will play a key role in shaping and advocating for policies that promote cleantech solutions, focusing predominantly on the German policy landscape. Working closely with FCA's Management and Cleantech Analysts, the position will translate analysis into science-based and actionable policy recommendations. Key tasks include:

- ▶ Track predominantly national policy and legislative initiatives related to cleantech solutions, providing comprehensive analysis on trends and advancements in cleantech innovation.
- ▶ Create future scenarios for cleantech adoption and contribute to policy recommendations, factsheets, and publications to incentivize cleantech solutions and decarbonization strategies.
- ▶ Collaborate with the EU Policy Manager and Cleantech Analysts to identify gaps in existing and proposed legislation, supporting the development and adoption of clean technologies.
- ▶ Engage with Policymakers: Proactively engage with federal and regional policymakers in Germany to foster collaboration, knowledge exchange and sustainable advocacy opportunities.
- ▶ Stakeholder Management: Organize events and in-person briefings that bring together policymakers, innovators, and industry representatives to catalyze the development and adoption of public policies needed to close the remaining innovation gaps.

### REQUIRED QUALIFICATIONS | EXPERTISE

- ▶ Master's degree or training/apprenticeship in a relevant field (such as political science, law, public administration, international relations, government studies) and at least five years of working experience in the German political system.
- ▶ Profound knowledge of German climate policy and regulatory frameworks in the focused fields. Knowledge of EU legislative process is a plus.
- ▶ High-level of formal and effective communication and networking skills to clearly convey technical concepts to non-technical senior political stakeholders (e.g. Members of State Federal parliaments, high-ranking ministerial representatives)
- ▶ Excellent command of English and German, both oral and written, strong ability to establish priorities and work to tight timelines within a fast-paced environment.
